

First Annual Mobile Mural Contest

“Public Works Connects Us”



Eligibility (Internet access is required)

To be eligible to participate in the City of Lompoc Mobile Mural Contest, you must satisfy the following criteria:

1. Entry into Contest:

- a. Access the Contest Rules and Complete the Contest Entry Form at www.cityoflompoc.com
- b. Artwork and Contest Entry Form must be emailed to:
mobilemuralpw@ci.lompoc.ca.us
- c. Limit one entry per Contest Period.

2. Participant Requirements

All school age (K-12) children and adults who reside in Lompoc or the Lompoc Valley.

3. The Artwork Entry must:

- a. Depict the participants interpretation of the (Theme), “**Public Works Connects Us.**”
- b. Be an original work of art with acrylics, crayons, oils, pencils, watercolors.
- c. Original artwork size no smaller than 11” x 17”.
- d. Be uploaded to the City’s website at a minimum high-resolution of (300dpi) digital format using either of the file types: PNG, Vector, BMP, JPEG.

- e. Have a minimum resolution of at least 2400 pixels x 2400 pixels.
- f. Have a maximum size of no more than 20 MB.
- g. Not contain copyrighted material; must be original work.
- h. Not contain threatening, offensive, or abusive material, as determined by the Public Works Director.
- i. Be otherwise in full compliance with the Official Rules.

4. Contest Period

Contest begins on March 24, 2017, at 12:01 a.m. and ends May 5, 2017, at 11:59 p.m.

All required Entry Information must be completed in full to be considered. Proof of delivery or receipt of any kind of Entry will not be deemed as proof of Entry. Any attempted form of Entry other than as described herein is void. Each Entry will be judged on the criteria set forth below. Entries that contain information that is not reasonably pertinent to the judging criteria (described below), as determined, or is otherwise in violation of these Official Rules will be disqualified. Any Entry that includes obscenities, objectionable material defames or invades the publicity or privacy rights of any person, living or deceased, or otherwise infringes upon any third party's personal or proprietary rights will be disqualified. Entries that are incomplete, illegible or corrupted are void and will not be accepted. Normal time, toll, connection and usage rates, if any, charged by your Internet service provider will apply and be your responsibility.

Selection of Winners: All Entries will be judged by City of Lompoc employees (collectively "Judges"). But note they may be reviewed on a rolling basis as they are received. All Entries will be judged by the Judges, who will select (1-2) winners from each age group (K-6th grades, 7-8th grades, 9-12th grades and adults).

Entries will be judged based upon the following criteria: (1) creativity and originality, (2) quality and execution, (3) adherence to the Theme, and (4) overall impression.

The City must receive entries from at least 12 different Entrants.

Winners, if any, will be announced on May 23, 2017. Notifications will be made via the contact information provided on the registration form.

Names of winners will be announced in local media and the City website.

Up to eight pieces of artwork will be selected on May 23, 2017 to be displayed on the side of our new refuse trucks and one of those will be chosen for our Public Works "Hall of Fame" to be hung in a designated location.

All artwork will be displayed on our City of Lompoc Public Works website for up to year.

Grant of Rights: Each Entrant unconditionally assigns and transfers all rights, title, interest, claim, ideas, concepts, copyrighted materials and trademarks contained in any Entry submitted in the Contest and any and all rights including “moral rights” in any Entry submitted in the Contest to the City of Lompoc. Each Entrant unconditionally assigns and transfers to City of Lompoc all rights, title, interest, and claim, which he/she now has, or may in the future have to his/her Entry (including any artwork submitted by the Entrant). City of Lompoc has the right to use, assign, reproduce, sell, modify, edit, adapt, dispose, and electronically alter Entrant’s Entry, in whole or in part, including, but not limited to, for moral rights, to appear in promotional and commercial materials without compensation or additional consent from Entrant, or any third party. Each Entrant waives voluntarily any and all claims as may arise under the Visual Arts Act of 1990 (17 U.S.C. § 106A and 113(d)), the California Art Preservation Act (Cal. Civ. Code § 987), or any other local, state, foreign or international law, as currently drafted or as may hereafter be amended, that conveys the same or similar rights, with respect to her/his entry. If the Entrant sends a written inquiry to the City Clerk asking whether the City is still using the art work and the City does not respond within 30 days after the City Clerk’s receipt of that inquiry indicating it is still using the art work, then the foregoing assignment, transfer and waiver shall be deemed null and void.

Limitations of Liability and Release: No liability or responsibility is assumed by the City of Lompoc, or resulting from any Entrant’s participation in or attempt to participate in the Contest. The City of Lompoc is not responsible for any typographical errors in the announcement of these Official Rules. All Entrants must have a valid e-mail address. Neither the City of Lompoc nor any of its officer, employees or agents shall have any responsibility or liability for technical problems or technical malfunction arising in connection with any of the following occurrences which may affect the operation of the Contest: hardware or software errors; faulty computer, telephone, television, cable, satellite, network, electronic, wireless or Internet connectivity or other online communication problems; errors or limitations of any Internet service providers, servers, hosts or providers; garbled, jumbled or faulty data transmissions; failure of any e-mail transmissions to be sent to or received; lost, late, delayed or intercepted e-mail transmissions; inaccessibility of the City’s website in whole or in part for any reason; traffic congestions on the Internet or the City’s website; unauthorized human or non-human intervention of the operation of the Contest, including without limitation, unauthorized tampering, hacking, theft, virus, bugs, worms; or destruction of any aspect of the Contest, or loss, miscount, misdirection, inaccessibility or unavailability of an account used in connection with the Contest. By participating in the Contest, each Entrant agrees to release and hold harmless the the City of Lompoc nor any of its officer, employees or agents from any and all claims, damages or liabilities arising from or relating to the Contest.

Publicity Release: Participation in Contest and acceptance of winning constitutes permission for the City of Lompoc to use, without notice or further compensation, each Entrant’s Entry, photo, likeness, biographical information, statement and voice in any and all media for any purpose, including without limitation, advertising and promotional purposes as well as in, on or in connection with the City’s website or the Contest or other promotions,

and each Entrant hereby release the City of Lompoc nor any of its officer, employees or agents from any liability with respect thereto (each a “Publicity Release”).

General: By participating, each Entrant agrees to these Official Rules. The City of Lompoc reserves the right, at its sole discretion, to cancel, modify or suspend the Contest.
