

## **RESOLUTION NO. 5843(13)**

### **A Resolution of the Council of the City of Lompoc, County of Santa Barbara, State of California, Approval of the FY 2013-2014 Budgets for CDBG, Human Services, and HOME Funds, and Necessary Certifications and Authorizations Required by HUD**

WHEREAS, the Housing and Community Development Act of 1974, as amended, provides for assistance to local government to develop programs which create viable urban communities;

WHEREAS, the City participates with the County of Santa Barbara, and the Cities of Buellton, Carpinteria, and Solvang in the Santa Barbara Urban County Partnership to receive federal CDBG funds;

WHEREAS, the City participates with the County of Santa Barbara, and the Cities of Buellton, Carpinteria, Solvang, and Santa Maria in the Santa Barbara HOME Consortium to receive federal HOME Investment Partnerships funds;

WHEREAS, a community development needs assessment public hearing was noticed in the Lompoc Record newspaper on October 11, 2012, and held on October 29, 2012, to obtain public comments and proposals for inclusion in the Lompoc FY 2013-14 Annual Action Plan; and

WHEREAS, at the City Council meeting of May 21, 2013, Council took public testimony on the City's priorities for the use of its federal grants.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The Lompoc FY 2013-14 CDBG Budget (Summary Budget shown as Exhibit "A") is hereby adopted by the City of Lompoc.

SECTION 2. To comply with requirements of the Annual Action Plan and to properly administer the Community Development Block Grant, HOME and Human Service funds on behalf of the City of Lompoc, the City Administrator of the City of Lompoc, or designee, is hereby authorized to execute all necessary agreements, documents, and certifications (including, but not limited to, loan documents, demand statements, default notices, foreclosure actions, reconveyances, subordinations, loan workouts, assumptions, promissory notes, deeds of trust, escrow documents, Request for Release of Funds Form #HUD-7015.15, federal environmental review documents, all Section 108 loan documents and the attached certifications set forth as Exhibit "B").

SECTION 3. This Resolution shall take effect immediately upon adoption.
