**WHEREAS**, the City of Lompoc is party to Case Numbers LA-CO-100-M; LA-CE-555-M; LA-CE-564-M; LA-CE-585-M filed with the Public Employment Relations Board ("PERB"); and

**WHEREAS**, the City of Lompoc and Lompoc Police Officers' Association seek to settle the above cases prior to a finding.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**
