BUSINESS INFORMATION:

The Promenade Cab Company is based out of Santa Barbara. Their business address is 114 West Padre St #7, Santa Barbara, CA. 93105. 805-705-3456 Armen Tosunyan has filed an Certificate of Public Convenience and Necessity application with the City of Lompoc with the intent to open a second Taxi Cab Company in Lompoc. The company owner has indicated that Robert Perry is the company area coordinator and Mr. Perry will be the local contact person.

According to the attached application for certificate of public convenience and necessity completed by the business owner Armen Tosunyan, he has been providing taxi service for more than 12 years, and for the past 4 years in southern Santa Barbara County.

Mr. Tosunyan states in his application that the current level of taxi service to the City of Lompoc is spotty and non-existent after 2am.

VEHICLE INFORMATION:

Mr. Tosunyan is reporting that he currently has three vehicles for his proposed taxi fleet for the City of Lompoc.

On 12/30/2009, I ran vehicle registration information on the above listed vehicles. All of the vehicles have current registration, but they all indicate Insurance Information

Unknown. Two of the vehicles are registered in the name of Promenade Cab Company, 7722 Ventura Cyn Ave, Van Nuys, CA and the third vehicle is registered to Armen Tosunyan at the same address.

INSURANCE INFORMATION:

Attached is a copy of Mr. Tosunyan's insurance. The insurance company is American Business Insurance Svcs. This insurance policy is for \$1,000,000 per occurrence. The three above listed vehicles are also listed on this insurance policy.

RECORDS CHECK:

DOJ Criminal History Check: 12/21/2009 fingerprints were submitted to DOJ. On 12/30/2009, we received the return from DOJ showing; No criminal history.

DMV: On 12/31/2009, DMV check on Mr. Tosunyan shows that his class C driver's license is valid. Issued on 03/07/2007 and expires on 04/04/2012. He has no convictions, and no accidents.

Lompoc PD Records Check: On 12/30/2009 I checked LPD Alliance and LISLE and found NO RECORDS for Mr. Tosunyan.

OTHER BUSINESS LICENCES:

Attached to this report is a copy of the Business Certificate # 4233 from the City of Solvang for the Promenade Cab Company, which is dated 12/31/2009.

DRUG AND ALCOHOL ABUSE POLICY:

Mr. Tosunyan also attached a copy of his company policy on Drug and Alcohol abuse policy.

DETAILS:

The Promenade Cab Company, owner Armen Tosunyan has filed an Certificate of Public Convenience and Necessity application with the City of Lompoc with the intent to open a second Taxi Cab Company in Lompoc. The Promenade Cab Company is based out of Santa Barbara. Their business address is 114 West Padre St #7, Santa Barbara, CA. 93105. 805-705-3456 The company owner has indicated that Robert Perry is the company area coordinator and Mr. Perry will be the local contact person.

Mr. Tosunyan has submitted all of the required documents for a Taxi Company with the City of Lompoc. He has not submitted an application as a Taxi Cab Driver. He reports that Robert Perry will be one of the Taxi Cab drivers, but as this report, Mr. Perry hasn't submitted the necessary paperwork to complete his Taxi Driver permit.

This permit process has to go before the City Council for approval because of the fact that there is already another taxi cab company in Lompoc.

Based upon Mr. Tosunyan's statement about the need for a second taxi service. Mr. Tosunyan reports that there isn't a taxi service available after 2am in the City of Lompoc. This is a true statement, Lompoc Taxi stops making pick ups after 2am. Based on the fact that the second taxi service EZ Ride Taxi Service is no longer in business in Lompoc, due to the owner no longer being able to financially insure this business and vehicles, I feel that there is a need for a second taxi service in Lompoc.

I recommend approval of this permit. Mr. Tosunyan has been informed that any and all driver's will have to complete the permit process prior to them being able to drive within the City of Lompoc.

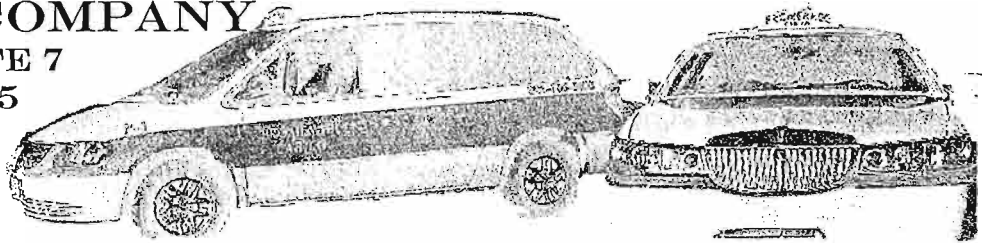





PROMENADE CAB COMPANY

Drug and Alcohol Abuse Policy

PROMENADE CAB COMPANY is committed to providing the community with safe transportation services. In keeping with this commitment, the company has adopted a variety of policies to ensure that taxi operators/driver/lessees of PROMENADE CAB COMPANY vehicles perform their duties safely, efficiently, and in a manner that protects their interests, the interests of PROMENADE CAB COMPANY, and most importantly the public who makes use of our services.

The goals of this policy would be severely compromised by drug or alcohol abuse during the operation of PROMENADE CAB COMPANY vehicles. PROMENADE CAB COMPANY has therefore adopted a strict policy regarding the inappropriate use or possession of drugs or alcohol. There are two components to this policy. The first involves a general prohibition against conduct that is detrimental to the objectives of the policy and the interests of PROMENADE CAB COMPANY and our vehicle lessees. The second involves methods of detecting inappropriate drug or alcohol use, including the testing prospective lessees for substance abuse.

1. General Rules

Lessee involvement with alcohol or drugs can be extremely disruptive and harmful to the work place. It can adversely affect the quality of work and the safe performance of our duties in operating motor vehicles; it can pose a serious safety and health risk to the user and others, and have a negative impact on work efficiency and productivity. Accordingly, PROMENADE CAB COMPANY requires all driver/lessees to report to work fit to perform their duties and prohibits the use or possession of alcohol or illegal drugs while operating PROMENADE CAB COMPANY leased vehicles, or their use for the eight hour period immediately prior to operation of PROMENADE CAB COMPANY leased vehicles. All lessees must adhere to the rules in this policy.

The use, possession, distribution, transfer or sale of illegal drugs or alcohol, or being under the influence of drugs or alcohol, is strictly prohibited while on duty, while on the company's premises or while operating a vehicle or potentially dangerous equipment owned or leased PROMENADE CAB COMPANY. Any violation of this policy may result in disciplinary action, up to and possibly including immediate termination of a PROMENADE CAB COMPANY lease.

Any driver/lessee who is under the influence of any prescribed medication must advise his supervisor of that fact, the precise type of medication involved, and the possible hazardous side effects of that medication, before operating any PROMENADE CAB COMPANY leased vehicle.

2. Inspections to Administer and Enforce Policy

In order to promote a safe, productive and efficient work place, PROMENADE CAB COMPANY reserves the right to inspect driver/lessees, as well as any articles and property in their possession, while operating PROMENADE CAB COMPANY leased vehicles. The company also reserves the right to inspect lockers, desks, boxes, company vehicles, personal vehicles on company property, packages, lunch boxes, containers, articles in such areas, and other objects brought onto

PROMENADE CAB COMPANY property or vehicles that might conceal alcohol, illegal drugs, and/or other inappropriate materials.

3. Testing Lessee Drivers

A driver/lessee may be asked or required to submit to testing procedures designed to detect the presence of drugs and/or alcohol either with or without cause. By way of example only, testing may be required if a driver/lessee (a) is acting in a manner that leads to a suspicion that he/she either possesses, controls, or is under the influence of a drug and/or alcohol, (b) was directly or indirectly involved in a work-related accident or mishap, (c) performs safety-sensitive, safety-related, or security sensitive work, or (d) is suspected that he has or may have been involved in the use, possession, transfer, distribution, manufacture, and/or sale of drugs or alcohol in PROMENADE CAB COMPANY controlled areas, on PROMENADE CAB COMPANY owned property, while driving PROMENADE CAB COMPANY leased vehicles, or while operating any other PROMENADE CAB COMPANY owned or leased vehicle or potentially dangerous equipment.

A request for testing does not necessarily mean or imply that a driver/lessee is under the influence of any improper substance or has violated any policy. However, such testing may be requested or required when PROMENADE CAB COMPANY determines that it is appropriate to promote the interests of this policy. Any driver/lessee of a PROMENADE CAB COMPANY vehicle who does not consent to and cooperate fully with any search and/or medical testing procedure is subject to discipline up to and possibly including immediate termination of PROMENADE CAB COMPANY lease.

Additionally, PROMENADE CAB COMPANY driver/lessees shall, upon request of competent law enforcement personnel, consent to medical testing for illegal drug or alcohol use, whether as part of an accident or incident investigation or not.

4. Testing Prior to Vehicle Leasing

Prospective PROMENADE CAB COMPANY driver/lessee applicants may be asked to submit and pass testing procedures that are designed to detect the presence of illicit drugs and/or alcohol. All offers of PROMENADE CAB COMPANY vehicle leases to such applicants will be conditional upon the successful completion of the testing procedure.

All PROMENADE CAB COMPANY driver/lessees are asked and expected to cooperate fully with PROMENADE CAB COMPANY in connection with the administration of this policy. PROMENADE CAB COMPANY driver/lessees must fully comply with these requirements.

Return the attached forms to the City Clerk's Office:

1. **“Application for Certificate of Public Convenience and Necessity”** (Taxicabs). There is a \$100.00 Investigation Fee, which is Non-Refundable. *Make checks payable to the “City of Lompoc.”*
2. **“Application for Taxicab Owner’s Permit.”**
3. **“Application for Taxi Driver’s Permit.”** Renewed annually through the Lompoc Police Department (LPD).

The above applications will be forwarded to the Lompoc Police Department for review and approval.

There is a \$25.00 permit fee per taxicab, per year. This is obtained after approval from the LPD (*Permit issued through the City Clerk’s Office*).

The taxicab business is required to have a Business Tax Certificate (BTC). The fee is based on gross receipts, only in Lompoc. (*BTC is obtained through the City Clerk’s Office once approved*). If drivers are independent contractors they are required to have a BTC.

Additional Forms Required and Obtained From the Lompoc Police Department:
