

**PUBLIC NOTICE CITY OF LOMPOC UNCLAIMED PROPERTY**

The said monies may be released to the depositor, their heir, beneficiary, or duly appointed representative provided that a claim form has been completed with the necessary information. If rejected by the Treasurer, the party who submitted the claim may file a verified complaint seeking to recover all, or designated portion, of the money in a court of competent jurisdiction within the County of Santa Barbara. A copy of the complaint and summons issued thereon must be served to the Treasurer within thirty (30) days of the notice of rejection. The Treasurer shall then withhold the release of the portion of unclaimed money for which the court action has been filed, pending final decision of the court.
