A request by Leigh Garcia, representing Familia De Dios Baptist Church, for Planning Commission consideration of a proposal for a Conditional Use Permit to allow operation of a church in an existing building located at 117 South J Street (Assessor Parcel Number 91-102-06), in the Planned Commercial Development (PCD) Zoning District. A Negative Declaration has been prepared pursuant to the California Environmental Quality Act (CEQA).

AUTHORITY:

The Planning Commission has the authority to approve, conditionally approve, modify, or deny a Conditional Use Permit (LCC Section 8882 d).

BACKGROUND:

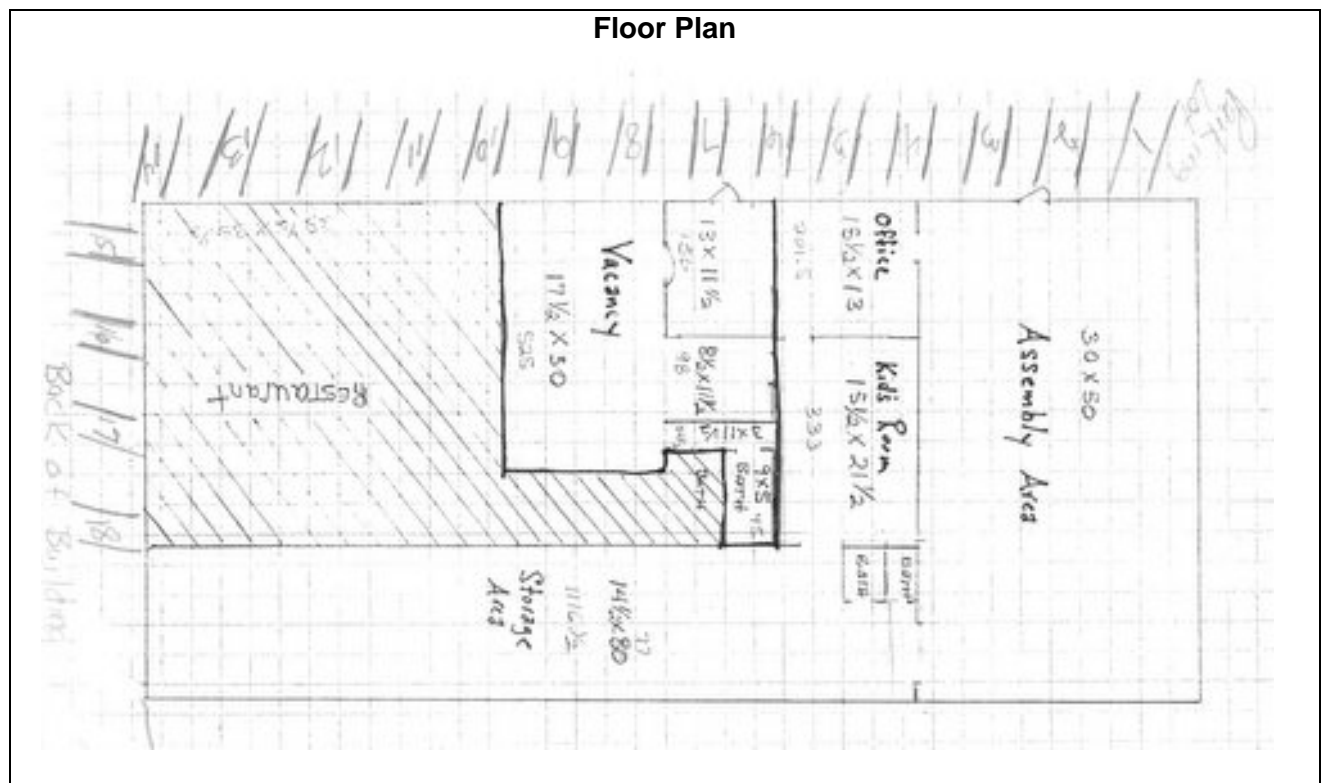

Construction of original commercial building

PROPOSAL:

The proposal is for a Conditional Use Permit to operate a church in an existing 3,190 square-foot commercial suite located at 117 South J Street (Assessor Parcel Number: 91-102-06). The site is located in the Planned Commercial Development (PCD) Zoning District and a church is listed as a use requiring a Conditional Use Permit.

The church would contain an approximately 1,500 square-foot general assembly area, 200 square-foot office, 330 square-foot children’s classroom, 1,160 square-feet of general storage, and restrooms. The church is proposing to hold services on Wednesday evenings from 6:30 p.m. to 9:00 p.m., Fridays from 7:30 p.m. to 10:00 p.m., and Sundays from 9:30 a.m. to 12:00 p.m. There are no changes proposed to the exterior of the building.



CONFORMANCE WITH ADOPTED CITY POLICIES:

Zoning Ordinance:

The proposed church is located within the *Planned Commercial Development (PCD)* Zone, which is intended to provide for the orderly development of commercial centers. Existing nearby uses include various commercial businesses and a city parking lot. As conditioned, the proposed church would be compatible with the current businesses. The CUP process allows the Commission to evaluate each project individually and ensure compatibility with existing uses.

Section 8303 Uses Permitted Subject to Obtaining a Conditional Use Permit states:

8. *Churches, subject to the following limitations, in addition to conditions, which would be made standard conditions for any Conditional Use Permit proposal:*
 - a. *Proposed church uses or activities shall not restrict the operation of any adjacent commercial or industrial use.*

The proposed hours of operation for church services on weekends and Wednesday and Friday evenings would not conflict with normal business hours.

- b. *The Planning Commission shall review for renewal all Conditional Use Permits for churches in the PCD zone after a period of three (3) years. Approval for continuing a church in the PCD zone after the initial three-year period shall be contingent upon the applicant demonstrating the availability of said property has been actively advertised for PCD uses for a period of not-less-than three months, without resulting in a commercial-industrial tenancy.*

A Condition of Approval (COA P15) is included requiring Planning Commission review of the Conditional Use Permit by June 12, 2009, if the church continues to operate in the same location.

- c. *The Planning Commission will not allow child care programs, including Vacation Bible School, or other church activities, that would occur between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, in consideration of any conditional use permit application.*

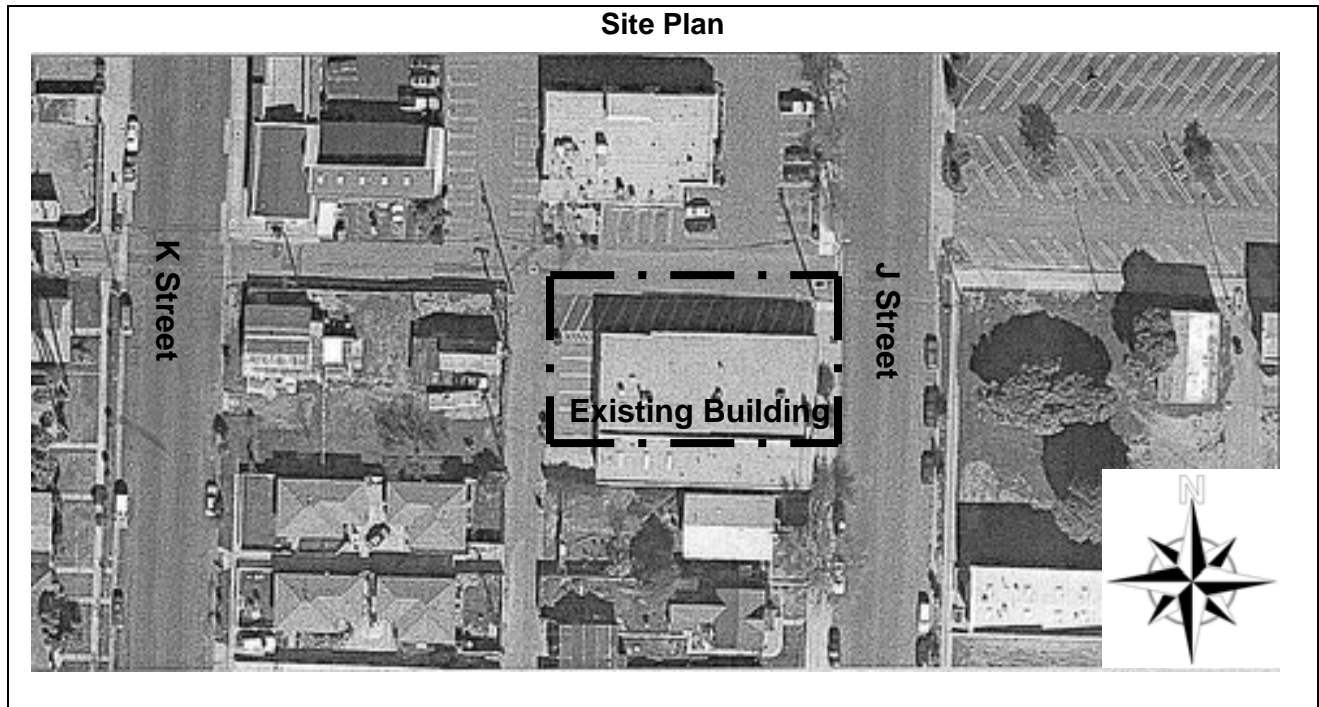
A Condition of Approval (COA P16) is included limiting the hours of church services. Church office hours would not be limited.

- d. *That the proposed church use be limited to existing buildings within the PCD zone.*

Staff has reviewed the adjacent uses and determined that they are compatible with the proposed church use.

Site Plan:

A restaurant occupies one of the three on-site commercial suites, with the remaining two spaces currently vacant. The applicant is proposing to operate a church in the suite closest to J Street and is not proposing external modifications to the building. Building plans will be submitted to the City Building Division for the proposed tenant improvements required to convert the suite to an assembly use (COA B2).



Parking –

Churches are required to provide *1 space for each 5 permanently located seats or 1 space for each 35 sq. ft. of gross floor area in the assembly room or rooms per Section 8851 Schedule of Off-Street Parking Requirements of the Zoning Ordinance.*

The project site currently has 18 striped parking spaces. A Condition of Approval (COA P17) is included requiring that a Floor Plan be submitted illustrating no more than 80 permanent seats before an approved change of occupancy can occur. The proposed hours of operation are generally not heavy retail hours and the on-site parking appears to be adequate to handle this application as a consolidated use, allowed by Zoning Ordinance Section 8856, with no additional parking requirement. A City-owned public parking lot is located less than fifty-feet from the proposed church.

Signage –

There is no request for review of signage with the proposal. Signage can be reviewed by staff for conformance with City regulations (COA P7).

Based upon the information provided on the plans and the conditions imposed upon the project, the use would be in conformance with the Lompoc City Zoning Ordinance.

Staff Review:

A Development Review Board (DRB) meeting was not held for this project as the use is proposed in an existing vacant building with minimal proposed modifications. The proposal was reviewed by the Building Division and Engineering Division. No project specific Conditions of Approval were received.

The Development Review Board (DRB) has developed a series of standard conditions of approval (COA) to advise applicants of possible requirements during the development review process. Project specific conditions are included when staff can determine what they should be from the conceptual plans provided for Commission review. A complete plan check occurs after construction plans have been submitted to the Building Division for building permits. Please note that not all COA included with the Planning Commission Resolution for the project may be applicable. If the applicant has questions and/or concerns regarding specific conditions, he/she should contact the department/division that is recommending the condition. DRB members do not attend the Commission meeting and Planning staff cannot answer specific questions regarding conditions recommended by other departments/divisions.

Staff recommends approval of CUP 06-02 subject to the attached Conditions of Approval.

ENVIRONMENTAL DETERMINATION:

An Initial Environmental Study has been performed for the proposed use. Pursuant to the provisions of the California Environmental Quality Act (CEQA), a Negative Declaration has been prepared. It is recommended that the Commission review the document and certify the Negative Declaration for the proposal. A Notice of Determination will be filed following the Planning Commission action.

NOTICING:

On May 19, 2006:

- 1) Notice of the Public Hearing was published in the Lompoc Record;
- 2) Notices were mailed to property owners within 300 feet by US mail; and
- 3) The project site was posted by City staff.

APPEAL RIGHTS:

Any person has the right to appeal the Planning Commission action to the City Council within ten days of the action. Contact a Planning Division staff member for the required appeal form, the fee is \$35.10.

RECOMMENDATION:

Staff recommends that the Planning Commission:

- 1) **Certify the Negative Declaration; and,**
- 2) **Adopt Resolution No. 487 (06) approving CUP 06-02, based upon the Findings of Fact in the Resolution and subject to the attached Conditions of Approval.**

RESOLUTION NO. 487 (06)

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF LOMPOC APPROVING A CONDITIONAL USE PERMIT TO ALLOW FAMILIA DE DIOS BAPTIST CHURCH TO OPERATE A CHURCH AT 117 SOUTH J STREET (CUP 06-02)

WHEREAS, a request was submitted by Leigh Garcia, representing Familia De Dios Baptist Church, for Planning Commission consideration of a Conditional Use Permit (CUP 06-02) to operate a church in an existing building at 117 South J Street (APN: 91-102-06); and

WHEREAS, the matter was considered by the Planning Commission at a duly-noticed public meeting on June 12, 2006; and

WHEREAS, at the meeting of June 12, 2006, _____, was present and answered Planning Commissioners' questions and addressed their concerns; and

WHEREAS, at the meeting of June 12, 2006, _____ spoke in favor of, and _____ spoke in opposition to, the proposal.

NOW, THEREFORE, THE PLANNING COMMISSION OF THE CITY OF LOMPOC RESOLVES AS FOLLOWS:

SECTION 1: After hearing testimony, considering the evidence presented, and due deliberation of the matters presented, the Planning Commission finds that the proposed church operation, as conditioned, meets the requirements of the Lompoc City Code and is consistent with the applicable policies and development standards, therefore it can be found that:

- A. The proposed use, as conditioned, is consistent with the applicable policies and development standards set forth in Lompoc City Code Section 8003.
- B. The site for the proposed use is adequate in size and topography to accommodate said use, and all yards, spaces, walls and fences, parking, loading, and landscaping are adequate to properly adjust such use with the land and uses in the vicinity.
- C. The conditions stated in the decision are deemed necessary to protect the public health, safety, and welfare.
- D. The site of the proposed church operation relates to streets and highways adequate in width and pavement to carry the quantity and kind of traffic generated by the proposed use.

- E. The proposed church operation will have no adverse effect upon the abutting and surrounding property from the permitted use thereof.

SECTION 2. Pursuant to Public Resources Code Section 21089 and Section 15074 of the California Environmental Quality Act Guidelines, the Initial Environmental Study and Negative Declaration which have been prepared for the proposal show no substantial evidence that the project may have a significant effect on the environment, and therefore it can be found that:

- F. The proposed church operation, as conditioned, does not have a significant effect on the environment; and
- G. Any effect of the proposed use upon fish and wildlife is de minimis and therefore no filing fee is required pursuant to the Fish and Game Code Section 711.4.

SECTION 3. Based upon the foregoing CUP 06-02 is approved as proposed on June 12, 2006, subject to the conditions attached as Exhibit A which are incorporated by reference as if fully set forth herein.

**CONDITIONS OF APPROVAL
CUP 06-02– FAMILIA DE DIOS BAPTIST CHURCH
117 SOUTH J STREET – APN: 91-102-06**

The following Conditions of Approval apply to the plans for Familia De Dios Baptist Church, received by the Planning Division and date stamped on April 17, 2006, and reviewed by the Planning Commission on June 12, 2006.

I. PLANNING

Planning - General Conditions

- P1. All applicable provisions of the Lompoc City Code are made a part of these conditions of approval in their entirety, as if fully contained herein.
- P2. In conformity with Sections 8900, 8935, and 8936 of the Lompoc City Zoning Ordinance, the violation of any condition listed herein shall constitute a nuisance and a violation of the Lompoc City Zoning Ordinance and the Lompoc City Code. In conformity with Section 0107 and 0128 of the Lompoc City Code, a violation of the Lompoc City Code and the Lompoc City Zoning Ordinance is a misdemeanor and shall be punishable as provided by law. In addition to criminal penalties, the City may seek injunctive relief to specifically enforce the Conditions of Approval. The applicant agrees to pay for all attorney's fees and costs, including, but not limited to, staff time incurred by the City in obtaining injunctive relief against the applicant as a result of a failure of the applicant to fully perform and adhere to all of the Conditions of Approval.
- P3. The applicant is advised that certain fees and charges will be collected by the City prior to issuance of building permits and/or prior to issuance of certificates of occupancy.
- P4. These conditions of approval shall be noted on the construction drawings filed for any building permits, including the Planning Commission resolution number and the applicant's signed affidavit agreeing to comply with the conditions.
- P5. All revisions made by the Planning Commission and specified in the planning conditions of approval shall be shown on a revised site plan, which shall be reviewed by the Planning Division prior to submittal of construction drawings.
- P6. Minor changes to the site plan, architectural elevations, or landscape plans shall be reviewed by the Community Development Director and approved if acceptable. Major changes to the site plan, architectural elevations, or landscape plans shall be reviewed by the Planning Commission and approved if acceptable.
- P7. Prior to the installation of any signage or sign related construction the applicant shall obtain all appropriate permits. Approval of these plans with signage indicated does not imply approval of signage.

- P8. Owner agrees to and shall indemnify, defend, protect, and hold harmless City, its officers, employees, agents and representatives, from and against any and all claims, losses, proceedings, damages, causes of action, liabilities, costs and expenses, including reasonable attorney's fees, arising from or in connection with, or caused by (i) any act, omission or negligence of Owner, or their respective contractors, licensees, invitees, agents, sublessees, servants or employees, wherever on or adjacent to the Property the same may occur; (ii) any use of the Property, or any accident, injury, death or damage to any person or property occurring in, or on or about the Property, or any part thereof, or from the conduct of Owner's business or from any activity, work or thing done, permitted or suffered by Owner or its sublessees, contractors, employees, or invitees, in or about the Property, other than to the extent arising as a result of City's sole active negligence or to the extent of any willful misconduct of the City; and (iii) any default in the performance of any obligations of Owner's part to be performed under the terms of this Agreement, or arising from any negligence of Owner, or any such claim or any action or proceeding brought thereon; and in case any action or proceedings be brought against the City, its officers, employees, agents and representatives, by reason of any such claim, Owner, upon notice from City, shall defend the same at its expense by counsel reasonably satisfactory to City.

Owner further agrees to and shall indemnify, defend, protect, and hold harmless the City, its officers, employees, agents and representatives, from and against any and all actions brought by any third party to challenge the Project or its approval by the City, including environmental determinations. Such indemnification shall include any costs and expenses incurred by Agency and City in such action(s), including reasonable attorney's fees.

Planning - Conditional Use Permit Conditions

- P9. The right to use an occupancy permit shall be contingent upon the fulfillment of any general and special conditions imposed by the conditional use permit procedure.
- P10. All of the special conditions shall constitute restrictions running with the land and shall be binding upon the owner of the land, his successors or assigns and a covenant to the effect may be required.
- P11. All of the conditions shall be consented to in writing by the applicant.
- P12. The resolution granting the application, together with all consent forms and a description of the property shall be recorded by the Recorder of the County of Santa Barbara prior to start of operation of the arcade.
- P13. The use permit granted is conditioned upon the rights or privileges acquired thereby being utilized within one year after the effective date of approval, and should the rights or privileges authorized hereby fail to be executed or utilized within said year, or when a building permit has not been issued within said year, or

when some form of work is involved which has not actually commenced within said year, or if so commenced, is null and void; unless such permit has not been utilized or such construction work started or completed within such one year period by reason of delays caused by the City in approving plans, in which event the Community Development Director shall grant and record a commensurate extension. The Planning Commission may, at its discretion, and with the consent or upon request of the permittee, for any cause, grant a reasonable extension of time in addition to the one (1) year period hereinabove provided. Such a request for extension shall have been filed with the Secretary of the Planning Commission fifteen (15) days prior to the expiration of the one (1) year.

- P14. This Conditional Use Permit may be reviewed and reconsidered by the Planning Commission at any time for the purpose of imposing new conditions to mitigate a nuisance or to revoke the permit to abate a nuisance.

Planning – Project Specific Conditions

- P15. This Conditional Use Permit (CUP 06-02) shall be reviewed by the Planning Commission for renewal on or before June 12, 2009.
- P16. There shall be no childcare programs including Vacation Bible School, or other church services occurring between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday.
- P17. A Floor Plan shall be submitted illustrating no more than 80 permanent seats before an approved change of occupancy can occur.

II. BUILDING AND FIRE SAFETY

Building - General Conditions

- B1. Project shall comply with the most recent adopted City and State building codes.
- B2. Plans shall be submitted by a California licensed architect and/or engineer. The building shall be required to comply with the new occupancy use according to the most recently adopted building and fire codes.
- B3. Approved fire-resistive assemblies shall be provided for occupancy and/or exterior wall protection. Parapets may be required in accordance with the UBC and UFC.
- B4. Dimensioned building setbacks and property lines, street centerlines, and between buildings or other structures shall be designated on plot plans.
- B5. All property lines and easements must be shown on the plot plan. A statement that such lines and easements are shown is required.

- B6. The Title Sheet of the plans shall include:
 - a. Occupancy group
 - b. Description of use
 - c. Type of construction
 - d. Height of the building
 - e. Floor area of building(s)
- B7. California disabled access regulations shall be incorporated within the plans. All areas within tenant space shall be made to comply with the most currently adopted disabled access standards.
- B8. Stairs, decks, platforms shall meet the strict guidelines in the most recent adopted Building Code.
- B9. Buildings shall comply with the State's Energy Regulations.

III. FIRE

- F1. An approved key box containing appropriate keys to buildings shall be made accessible and installed according to City Standards.
- F2. All fire extinguishers required to have an 'A' rating shall have a minimum rating of 2A10BC. Location, number and types shall be in accordance to UFC Standard 10-1.
- F3. Exits, exit lighting, panic hardware and exit signage shall comply with the most recently adopted fire code.
