Dear City Recreation Department,

My name is Olivia Magana and I am the Vice President of the Lompoc Tsunami Swim Team Board.

The Lompoc Tsunami Swim Team is currently organizing a "Toys for Tots Swim Meet" which will take place on December 6 and 7, 2025 at the Lompoc Aquatic Center. We are inviting several swim teams from surrounding areas including: Arroyo Grande, Santa Maria, Santa Barbara, San Luis Obispo, and Carpinteria. This two day competitive event will provide economic benefit to the City of Lompoc by bringing many visitors (athletes and family members) to the city.

The swim meet is the annual fundraiser for the non-profit Lompoc Tsunami Swim Team. We are reaching out to to the Parks and Recreation Commission to request a Parks & Recreation Commission Sponsorship. The sponsorship will assist the Lompoc Tsunami Team with the city-related fees associated with the rental of the Lompoc Aquatic Center. If the sponsorship is awarded, the money will be used to offset the rental fees the City would impose for the event.
