RESOLUTION NO. 6793(25)

**A Resolution of the City Council of the City of Lompoc,
County of Santa Barbara, State of California,
Approving Amendment No. 1 to the Memorandum of Understanding
Between the City of Lompoc and the Lompoc Police Officers' Association, and
Approving Supplemental Appropriations**

WHEREAS, on July 15, 2025, the City Council approved the Memorandum of Understanding between the City of Lompoc (City) and the Lompoc Police Officers' Association (LPOA) effective July 1, 2025, through June 30, 2027 (LPOA MOU 2025-27) with the adoption of Resolution No. 6765(25); and

WHEREAS, the City and LPOA authorized labor relations representatives met and conferred in good faith regarding health benefit contribution adjustments; and

WHEREAS, on December 3, 2025, the parties have jointly prepared and ratified Amendment No. 1 to the LPOA MOU 2025-27 (Amendment No. 1), attached hereto as Exhibit A, to reflect those adjustments; and

WHEREAS, the City Council now desires to approve Amendment No. 1 to reflect the proposed health benefit contribution adjustments; and

WHEREAS, the City Council also desires to approve supplemental appropriations to fund the benefits contribution adjustments.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The Amendment No. 1 to the LPOA MOU 2025-27 attached hereto as Exhibit A, which provides for health benefit contribution adjustments, is hereby approved.

SECTION 2. Supplemental appropriations to fund the benefit contribution adjustments in the remaining Biennial Budget Fiscal Years 2025-27 due to the City's increased health premium contributions in Amendment No. 1 and supplemental resources from various Fund Balance Accounts to fund the supplemental appropriations are hereby approved and authorized as indicated in Exhibit B attached hereto.


SECTION 3. Effective Date. This Resolution is effective upon its adoption.

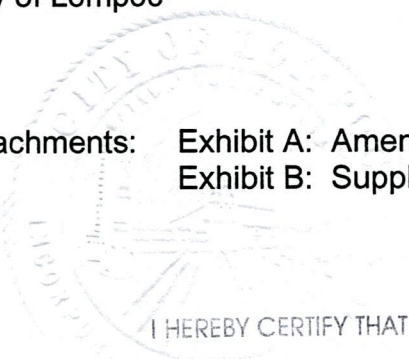

AMENDMENT NO. 1

MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF LOMPOC AND THE LOMPOC POLICE OFFICERS' ASSOCIATION EFFECTIVE JULY 1, 2025 THROUGH JUNE 30, 2027

This Amendment No. 1 to the Memorandum of Understanding between the City of Lompoc and the Lompoc Police Officers' Association Effective July 1, 2025 through June 30, 2027 (LPOA MOU 2025-27) is made and entered into by and between the City of Lompoc, a municipal corporation (City), and the Lompoc Police Officers' Association (LPOA).

RECITALS:

WHEREAS, on July 15, 2025, the City Council approved the Memorandum of Understanding between the City of Lompoc (City) and the Lompoc Police Officers' Association (LPOA) effective July 1, 2025, through June 30, 2027 (LPOA MOU 2025-27) with the adoption of Resolution No. 6765(25); and

WHEREAS, the City Council shall at its regular meeting on December 16, 2025, determine whether or not to accept, approve, and adopt this Amendment No. 1 to the LPOA MOU 2025-27 to reflect the proposed health premium contributions delineated below.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and subject to the formal City Council action described above, the parties hereto agree to the proposed increase in health premium contributions as prescribed below:

- **HEALTH AND WELFARE BENEFITS**

In January 2024, the City provided additional medical premium contributions to LPOA-represented employees as follows: \$25 additional to one party, \$70 additional to two-party, and \$95 additional to family coverage per month.

Effective beginning of the 2026 Health Plan Year, the City and LPOA agree that after the City Council adopts a resolution, the City shall provide LPOA-represented employees increased medical contributions as follows: an additional \$127 per month for one-party coverage, an additional \$255 per month for two-party coverage, and an additional \$330 per month for family coverage. This increased contribution applies to the 2026 Plan Year rates, including the January 2026 premium, which is deducted from December 2025 payroll.

The proposed new employer's monthly contributions **effective January 1, 2026**, are:

AMENDMENT NO. 1 TO THE LPOA MOU JULY 1, 2025 THROUGH JUNE 30, 2027

Any premium adjustments will be reimbursed to employees enrolled in the City's health plan as of January 1, 2026. The premium reimbursement will be processed in the February 2026 payroll.

The representatives of the City and LPOA have jointly prepared Amendment No. 1 to the LPOA MOU 2025-27 and jointly presented the same to the City Council of the City of Lompoc for determination pursuant to Government Code Section 3505.1. Except as expressly provided for in Amendment No. 1 to the LPOA MOU 2025-27, all other provisions of the LPOA MOU shall remain in full force and effect. The parties also acknowledge that Amendment No. 1 to the LPOA MOU 2025-27 shall not be in full force and effect until adopted by resolution by the City Council of the City of Lompoc. Subject to the foregoing and in witness whereof, this Amendment No. 1 is hereby executed by the authorized representatives of the City and LPOA and entered into this 3rd day of December 2025.
