
Chairperson Gallacher made a motion to approve the voting decisions and Commissioner Weir seconded the motion, it passed 4/0.

**STAFF ITEMS:** There were no staff items discussed at this meeting.


**COMMISSIONER REQUESTS:** There were no commissioner requests discussed at this meeting.
